# **Defining Innovation**

## What is meant by the term innovation?

Innovation is defined in many ways both nationally and within Dorset. Therefore a key component of the initial work undertaken by the Dorset Innovation Hub (DIH) was to review and agree what the term 'innovation' represents both within DIH as well as in the wider context.

Within the Dorset Innovation Hub

The DIH utilises the principles of the "Enabling innovation and adoption in health and social care – Developing a shared view" report (Feb 2021) by the Accelerated Access Collaborative NHSE, Care Quality Commission (CQC), National Institute for Health and Care Excellence (NICE) and partners. In this publication, the AAC/CQC use "the term



innovation to cover both inventive (creating new ideas, products, services or models of care) and adoption (implementing what has worked elsewhere)." The AAC/CQC also state it is crucial that health and care systems are good at both so that new ideas are developed to solve problems and the best ones spread quickly.

#### Wider context

To support the evaluation work of the DIH, the DIH Evaluation Working Group developed the following set of definitions to characterises key aspects of the DIH work programme. *Innovation* – "Innovation is the intentional introduction of new approached, practices, treatment, technologies and services within a health and care role, team, organisation, or system, which are designed to improve the health of the Dorset population." *Innovation Culture* – "An innovation culture occurs when individuals, teams, organisations and system leaders, are receptive to innovation adoption, and provide the infrastructure needed to proactively facilitate innovation initiatives and their implementation."

## Innovation Adoption –

"Innovation is not just about the originating idea, but also the whole process of the successful development, implementation and spread of that idea into widespread use. This includes; scale up, spread and sustainability."

# **NHS Innovation Accelerator**

The <u>NHS Innovation Accelerator</u> (NIA) is an NHS England and NHS Improvement (NHS E&I) initiative that supports delivery of the NHS Long Term Plan priorities by accelerating uptake of promising innovations for patient, population, and NHS staff benefit, and providing real time practical insights on spread to inform national strategy.



Launched in 2015, the NIA is commissioned by the Accelerated Access Collaborative at NHS E&I and is delivered in partnership with the 15 Academic Health Science Networks (AHSNs).

As part of an annual call, the NIA invites applications from exceptional individuals representing innovations that meet a real need within the NHS. Applications undergo a robust, multi-stage assessment process involving a college of expert patient, clinical and commercial assessors. This panel is drawn from a wide range of organisations, including NHS E&I, AHSNs, the National Institute for Health and Care Excellence (NICE) and The Health Foundation.

Successful applicants join an existing community of innovative individuals ('Fellows') with a passion for sharing their learning and expertise, which are collated in annual research reports and a quarterly INSIGHTS newsletter.

This year, 10 innovators have been selected and will receive support to introduce their solutions across England's NHS over the next three years. Innovations include Dem Dx, a CE-marked AI-enhanced Clinical Reasoning Platform, and Maxwell Plus, a breakthrough technology in diagnosing prostate cancer early.

To date, the NIA has supported 72 Fellows representing 74 innovations. More information about the NIA programme and the range of innovations being supported can be found on the <u>NIA website</u>.



# Med Tech Funding Mandate Policy

## What is it and how does it support innovation adoption?

In April 2021 the <u>MedTech Funding Mandate (MTFM) policy</u> was launched to support adoption of MedTech and diagnostic technologies across the NHS. This fulfilled a commitment in the NHS Long Term Plan to support commissioners and healthcare providers to bring life-changing innovations to patients quicker and built on the previous Innovation Technology Tariff and Innovation Technology Payment initiatives.

The selected technologies supported by the MTFM need to meet criteria of saving costs and resources, with the potential to make a return on investment within three years. Technologies covered by the MTFM policy are funded by commissioners from their existing allocations, with hospitals and commissioning organisations expected to comply with the policy guidance where appropriate.

The MTFM is now going into its second year. Technologies supported in 2021/22 have remained on the policy and have been joined by seven new technologies for 2022/23.

The technologies supported in 2021/22 were **Placental growth factor-based testing (PIGF)** – a blood test to rule out preeclampsia in pregnant women, **SecurAcath** – for securing percutaneous catheters, **HeartFlow**, which creates a 3D model of a patient's coronary arteries and assesses the extent and location of blockages, and **gammaCore** – a handheld device which alleviates the symptoms of severe cluster headaches.

The second year's mandate for 2022/23 includes four technologies involved in benign prostatic hyperplasia treatment, **UroLift**, **GreenLight XPS**, **Rezum** and the **PLASMA system**, and three for improving patient experience during procedures, the **XprESS** multi-sinus dilation system, the **Thopaz+** portable digital chest drain system, and the **Spectra Optia** Apheresis System, an apheresis and cell collection platform for the treatment of sickle cell disease.

The Dorset Innovation Hub has worked to implement 2021/22 technologies across relevant ICS organisations and is now engaging and working with relevant clinical and operational teams to consider and implement the new technologies included in the 2022/23 policy.

# **Support for Innovators**

## How the Dorset Innovation Hub can help innovators

The DIH provides advice and hands-on support to adapt, adopt and sustain proven innovation and develop ideas into new services and products that will benefit the Dorset community. How this support may look will depend on the focus of the project.

#### **Adopting Innovation Projects**

For projects focused on the adaption, adoption and spread of proven innovation solutions into practice, the DIH work as part of the project team to facilitate the project's development and delivery. Facilitative support may include elements such as; development of a project team, stakeholder analysis, horizon scanning, communications, and benefits realisation analysis. Support is tailored to the needs of the individual project, and is subject to approval and agreement from the DIH programme group.

#### **Inventive Innovation Projects**

For projects focused on developing ideas into new products and services, provision of support will depend on who your employer is. As the DIH is hosted by University Hospitals Dorset (UHD), inventive innovation projects at UHD are supported directly by the DIH. This may include; developing a business case, advice on intellectual property, information on funding opportunities and commercialisation options. Outside of UHD, contact your employee organisation to investigate support available for inventive innovation project. If needed, the DIH can help to establish the most appropriate point of contact.

# **Community of Practice**
